Communication in the anti-ragging system

The instructions about anti-ragging and related punishments if involved in ragging have been displayed in notice boards available in our college as detailed below.

- ❖ Separate Buildings for first year to final year students with separate interval timings.
- ❖ Separate hostels for boys and girls.
- ❖ Separate security for each Building.
- ❖ Warden and two resident tutors are available.
- ❖ Separate mobile phone is provided for Boys and Girls hostel wardens.
- ❖ Warden mobile number is displayed in all possible places in hostel.
- ❖ Helpline number for anti-ragging is displayed in all notice boards.
- ❖ Suggestion/complaint box are provided in each buildings so that the students can submit their complaints secretly.

The procedures to be followed in order to prevent ragging.

- ❖ In our prospectus the rules and regulations of anti-ragging and its related information's are printed.
- ❖ In the application form for college and hostel admission along with an affidavit (printed both English and Regional language (Tamil) is provided filled up and signed by the student as well as parent/guardian of the applicant.
- ❖ The same procedure is also applicable to the students who residing outside the college(Private room and Lodge)
- ❖ Before the commencement of academic session the head of the institution shall convene and address a meeting of various functionaries about into ragging in the campus.
- ❖ On the arrival of the fresh students after two week the orientation, sports and cultural programs are to be conducted to provide the platform for fresher's and seniors to interact in the presence of faculty members.
- ❖ At the end of the each academic year, a letter to be sent to all parents/guardians who are completing their first year to inform them about the rules and regulations, the Laws for the time being in force prohibiting ragging and punishments, appealing to desist from indulging in ragging on their return to the college at the beginning of next academic session.
- ❖ In the hostel warden addresses all students to instill a feeling of confidence among the fresher's.

System as a hole to be adopted for the smooth sailing for fresh engineering students

- ❖ In our college monitoring cell consists of Anti-Ragging Squad and mentoring Cell.
- ❖ Anti-Ragging committee members are vigil on the students before and after the classes are commencing and closing daily for about 30 minutes.
- ❖ In addition, this committee also visits frequent rounds (nearly 5 times) in the classes in a stipulated time throughout the college working hours.
- ❖ To bring best understanding, the interaction programs are conducted every fortnight between senior and junior students for first three months of the commencement of academic year.

- ❖ Anti-Ragging Squad maintains active, vigil; oversight and patrolling functions and keeps remain mobile, alert all times.
- ❖ In addition, this committee also makes surprise raids on hostels and other places of college campus.
- ❖ This committee is also responsible for conducting an on-the-spot enquiry into the incident of ragging if any refereed by the head of the institutions.
- ❖ Anti-Ragging Squad is resorted at odd hours during the first few months of academic session.
- ❖ Freshers are divided into small groups and each group will be assigned to a faculty member who acts as a mentor.
- ❖ Mentor will explain the rules and regulations of anti-ragging in and outside of the college premises.
- ❖ Apart from this, the mentor is solely responsible for all the activities of the students in the campus .Hence the mentor discuss with the students about the problems in the college as well as hostel periodically
